I really appreciated our conversation yesterday! I'm going to follow up shortly with the items I promised.

In the meantime, I just wanted to share this update along regarding the budget proposal that the White House unveiled. Overall, we're really pleased to see that President continue to make federal investments in the nation's election infrastructure a priority.

We're still pushing ahead within Congress using the \$400 million figure at this time since it's the figure that has received bipartisan support and has a greater chance of passing this year. The President's higher number may make this even more likely.

We really appreciate your advocacy on this issue and we'll be in touch soon to flag some more opportunities for local election officials like yourself to engage.
