

**FOIA PUBLIC RECORDS REQUEST REPORT (PRR)**  
**CORRESPONDENCE WITH ELECTION INFLUENCING ORGANIZATIONS**

Summary: Public Records Requests were sent out to all 16 Nevada counties and Carson City. Responses were received from 10 recipients.

Clark, Douglas, Esmerelda, Lyon, Mineral, Storey and Washoe Counties have never replied.

6 Recipients reported they had no correspondence with these groups.

4 Recipients requested an extended date to reply.

Eureka met their extended date, stating they had no correspondence with these groups

Nye and White Pine Counties have responded with documentation which is being reviewed.

Carson City has passed their extended date without any contact.

Carson City

On or about February 16, 2024 a FOIA PRR was sent to Scott Hoen, Clerk Recorder, Carson City Election Department requesting copies of any correspondence, including, but not limited to, emails, letters, meeting notes, or call notes between employees of Carson City and employees of the US Alliance for Election Excellence and/or The Elections Group.

On March 8, 2024, an email response was received from Benjamin Johnson, stating "I anticipate being able to respond with any records by April 12, 2024 by 5pm with any records, if any exist."

Churchill County

On or about February 16, 2024 a FOIA PRR was sent to Linda Rothery Clerk /Treasurer, Churchill County, requesting copies of any correspondence, including, but not limited to, emails, letters, meeting notes, or call notes between employees of Churchill County and employees of the US Alliance for Election Excellence and/or The Elections Group.

Bowling Clerk Recorder, Eureka County, requesting copies of any correspondence, including, but not limited to, emails, letters, meeting notes, or call notes between employees of Eureka County and employees of the US Alliance for Election Excellence and/or The Elections Group.

On March 11, 2024, an email response was received from Ashley E. Kemp, Administrative Legal Secretary, Eureka County District Attorney's Office, stating "This Office will provide you with an update on or before Thursday, March 21, 2024. On March 19, 2024, an email was received from Ashley E. Kemp, Administrative Legal Secretary, Eureka County District Attorney's Office, stating "After diligent searches by multiple individuals in the Eureka County IT Department and the Eureka County Clerk Recorder's Office, no records responsive to your request were located. Eureka County considers this records request closed."

## Humboldt County

On March 11, 2024, an email response was received from Jessica Koepke

Deputy Clerk, Humboldt County, stating “Humboldt County Clerk has not had any correspondence with the Elections Group or the US Alliance for Election Excellence since January 1, 2023.”

### Lander County

On March 12, 2024, an email response was received from Mark Kampf, County Clerk, Nye County, stating “Pursuant to NRS 239.0107.1.c.1., notice is hereby given that this office is unable to make any public records available at this time, and the earliest date and time that this office reasonably believes any public records may be available is on or before the close of business on 4/11/2024. If any public records are not available on or before 4/11/2024, this office will provide to you, in writing, an explanation of the reason the public records are not available and a date and time after which this office

reasonably believes the public records will be available. This office will make reasonable efforts to identify any applicable records and respond to your public records request as expeditiously as possible.”

On March 20, 2024, an email was received from Mark Kampf, County Clerk, Nye County, stating “The information you requested can be found in the below links to the .pst files.”

#### Pershing County

On or about February 16, 2024 a FOIA PRR was sent to Lacey Donaldson, Clerk-Treasurer, Pershing County, requesting copies of any correspondence, including, but not limited to, emails, letters, meeting notes, or call notes between employees of Pershing County and employees of the US Alliance for Election Excellence and/or The Elections Group.

On March 15, 2024, an email response was received from to Lacey Donaldson, Clerk-Treasurer, Pershing County, stating “I am in receipt of your request for any correspondence I have received and responded to from the US Alliance for Election Excellence and/or the Elections Group. I have not received any correspondence from either group, nor have I participated in any calls, etc.”

#### White Pine County
