Assistance Commission through the Arizona Secretary of State's office, in the amount of \$47,243.63, to initiate the Help America Vote Act 2023 Sub-Grant, for period of June 2024 through December 31, 2025, and approve corresponding budget amendments for revenues and expenditures, and authorize Siri Mullaney,

Finance Director, to sign all documents regarding the grant.

RECOMMENDED MOTION:

Approve a grant award from the U.S. Election Assistance Commission through the Arizona Secretary of State's office, in the amount of \$47,243.63, to initiate the Help America Vote Act 2023 Sub-Grant, for period of June 2024 through December 31, 2025, and approve corresponding budget amendments for revenues and expenditures, and authorize Siri Mullaney, Finance Director, to sign all documents regarding the grant.

BACKGROUND:

This grant funding primarily focuses on purchasing Ballot on Demand printers for use at vote centers. The intention is to expand the number of vote center locations from three (historically the number of vote centers) to fifteen throughout the County. The second project is to purchase void seals for all election equipment when sent to polling locations. The sub-grant funding allocation for Coconino County will not only support physical security and aid in voter access but also bolster voter confidence, ensure election integrity, and establish a more robust chain of custody.

The provision of voting equipment and seals will not only make voting easier and expand voter access through the expansion of vote centers throughout the County but also ensure the physical security of the devices while not in use during voting hours and provide a clear, written chain of custody for all usage of the voting equipment. Securing election devices enables more confidence in the voting processes, and the equipment makes voting easier.

In 2023, Coconino County Elections established a task force to evaluate vote centers throughout the County. The objective was to develop comprehensive guidelines for selecting polling locations. As a result of the review, an expansion of vote centers was proposed and subsequently

approved by the Board of Supervisors.

The unavailability of funds will not only deter the availability of other avenues the elections department uses to support voting, like voter outreach and non-essential operational expenses to cover the cost and meet the public request but also significantly impact voter access and confidence, which the pillars of a democratic process.

ALTERNATIVES:

The Board could elect not to accept the grant funds from the U.S. Election Assistance Commission. This alternative would prevent the Help America Vote Act 2023 Sub-Grant to increase election security and voter access.

RECOMMENDED MOTION:

Approve a grant award from the U.S. Election Assistance Commission through the Arizona Secretary of State's office, in the amount of \$47,243.63, to initiate the Help America Vote Act 2023 Sub-Grant for the period of June through November 2024, and approve corresponding budget adjustments for revenues and expenditures, and authorize Siri Mullaney, Finance Director, to sign all documents regarding the grant.

BACKGROUND:

In 2023 the United States Congress allocated \$75 million to the Help America Vote Act (HAVA) fund. The funds are distributed to each state to support the administration of federal elections, including enhancement in technology and security, voter accessibility, and voter education. The Arizona Secretary of State's office is distributing the funds to each county based on population formula.

Coconino County was allocated \$94,487.27 from the HAVA funds. These funds are to be divided in equal amounts of \$47,243.63 for the Recorder's Office and the Elections Department. The Recorder's Office is requesting the funds to be used to improve technology and security operations, voter accessibility, and voter education in Coconino County.

The projects financed by the HAVA 2023 grant are expected to be completed by November 2024. The County will report to the Arizona Secretary of State on a quarterly basis the progress of the HAVA grant projects.

ALTERNATIVES:

The Board could elect not to approve the grant award. This alternative would prevent the Recorder's Office from being able to use the grant funds to improve technology and security operations, voter accessibility, and voter education in Coconino County.

FISCAL IMPACT:

Budget amendment of revenues and corresponding expenditures in the amount of \$47,243.63.

- Ballot proofing project voters will have increased confidence in the election process if ballots are accurate
- Al social media project voters will have increased confidence in the election process if there is less mis- dis- and malinformation and fewer potential election threats online
- Voter education campaign voters will have more knowledge of voting requirements and deadlines, dates and locations, and accessibility options in order to exercise their right to vote
- Phone line improvements voters and election workers will have increased access to call our Tuba City office for assistance over the phone. This is our main office that assists voters that need Navajo and Hopi language assistance, so we need more than one line to receive phone calls at busy times.

Please describe in detail a clear and comprehensive plan for your requested project.

- Ballot proofing project We are working with the US Digital Response to implement this project. This would be an additional tool in our toolbox to help us proof ballots. Proofing ballots must be done in a very short time period so we hope this will assist us in ensuring our ballots are accurate.
- Al social media project We are working with the US Digital Response to implement this project. USDR is going to conduct trainings for the entire department and other county employees that assist elections so we have a better understanding of this changing and new environment that may be used to spread mis-, mal- or dis-information to our voters. We are especially concerned about its possible use targeting minority language voters in our county.



- Voter education campaign The best way to reach voters in the rural parts of our county is through an education program that will provide voting and elections information through radio and newspaper advertising and printed brochures. We want to expand our use of social media to reach more voters and we hope to contract or hire a person to assist us.
- Phone line improvements The Tuba City voter services office currently has only one phone line to receive incoming calls. Additional lines will be added to allow staff to handle multiple phone calls at once. The Navajo and Hopi languages are oral languages so voters that need language assistance have to talk with a person so they can be assisted.

If your project is not approved, please provide a detailed explanation on how this may affect your County.

- Ballot proofing project Ballots might not be as accurate and the proofing process will take longer and be less efficient.
- Al social media project There may be an increase in election threats online that are not identified or monitored.
- Voter education campaign There will be less education to voters in rural parts of our county.
- Phone line improvements It will be more difficult for the Tuba City office to receive phone calls and communicate with voters and election workers efficiently.

BACKGROUND:

Health and Human Services is in a collaborative grant project with the Sheriff's Office, the County Attorney, Public Defender, Adult Probation, Facilities, and contractual community partners to provide a re-entry program to individuals who have been incarcerated in the Coconino County Detention Facility.

The Public Works Fleet team was able to secure the two approved vehicles in FY24 instead of FY25. This is a budget adjustment to move the item into the current fiscal year.

ALTERNATIVES:

The Board could choose to decline the budget adjustment for FY24, which would result in a loss of \$88,000, which would be used to purchase two vehicles in realigned funding to support recently released incarcerated individuals.
